STANDARD CONDITIONS OF AGREEMENT

In this document, reference to a service(s) shall include testing performed by TEST Africa on behalf of the Applicant.

1. *Tests are carried out at the discretion of TEST Africa, which reserves the right to decline any application for performance of services.*
2. *A Test Report, will be furnished to the applicant on completion of the service, i.e. –*
 - *on compliance of the sample with the relevant standard / specification*
 - *a Non-Compliance Report listing only the failures when a sample fails to comply with the relevant standard / specification*
3. *The Test Report (in full or partly) shall not be reproduced or presented out of context.*
4. *The Test Report relates only to the specific sample(s) as received from the Applicant, tested and as identified in the Test Report. The test results do not apply to any similar item that has not been tested.*
5. *All appliances, components, etc. sent by the Applicant for service, shall be delivered and collected at the Applicants' cost and risk at the place of business of TEST Africa.*
6. *Although appropriate security measures are taken, TEST Africa shall not be responsible for any loss or damage to the goods received beyond the point of delivery.*
7. *Due to the destructive nature of the testing service(s), TEST Africa will not be responsible for any direct or indirect losses incurred as a result of such damage.*
8. *If any unforeseen problems or additional tests arise during the testing of the sample / appliance, TEST Africa reserves the right to alter the given estimation of cost in consultation with the Applicant.*
9. *The Applicant warrants that the signatory on the Test Application has been duly authorized to contract and act on the Applicants' behalf.*
10. *The Applicants' duly authorized signatory hereby binds himself/herself in his/her personal capacity as co-debtor jointly and severally for the full amount due to TEST Africa.*
11. *Test samples will not be released unless payment was made in full.*
12. *When a sample / appliance fails to comply with the specification the Applicant has no right to withhold payment.*
13. *The Applicant agrees to collect the tested samples / appliances at own cost on completion of the service(s). Samples not collected after a three month period will be destroyed.*
14. *The Applicant hereby indemnifies, hold harmless and absolves TEST Africa from any claims whatsoever in the event of legal action against the Applicant for samples / appliances not tested by Test Africa.*
15. *The application for letter of authority (LOA) is not for the SABS Mark and such wording shall not be used in any way for selling, packaging, displaying, offering for sale or advertising on the basis of the LOA issued by the NRCS.*
